TERMS & CONDITIONS

The following terms apply to all parties of 10 people or more. By paying your deposit you agree to the booking terms and conditions as set out below.

01. Your booking date is the date your table was reserved. Your reservation date is the date your table is booked for. Your reservation time is the time at which you must be seated at your table. If you wish to have pre-drinks please kindly make arrangements to arrive early and allow sufficient time to be seated on time.
02. The restaurant is unable to push back the time of your booking for late arrivals in consideration for other diners. In the event that your booking time has lapsed by a maximum of 15 minutes the management will aim to seat you at a time that it is capable of delivery once all other diners have been seated. If management is unable to do so then they will offer an alternative date without prejudice to any liability or our other terms and conditions. Management reserves the right to cancel your reservation in its entirety without any compensation or refund of deposit in the event of late arrival by more than 15 minutes.
03. Early sittings prior to 7.30pm will be subject to a 2 hour sitting.
04. Bookings will only be confirmed once a £10 per person deposit has been received. Provisional reservations can only be held for 7 days without a deposit. Deposits can be paid in person or through an online payment link.
05. Deposits are non-refundable, should your party size decrease in numbers, deposits received cannot be offset against your final bill.
06. Should you cancel a confirmed booking or party guest less than 12 hours before your reservation, we reserve the right to charge the full meal price.
07. All completed pre-orders must be received 7 days prior to your reservation date. Strictly no amendments can be made after this date.
08. Pre-orders can only be accepted via our online pre ordering system. Please note we cannot accept pre-orders over the telephone, in person or in any other format.
09. We reserve the right to cancel your booking without prejudice to any other clause in this agreement in case of late receipt of your pre-order.
10. Any additions to your booking will be made subject to availability and discretion of management.
11. We regret we are unable to accept payment by cheque, American Express or split bills. You hereby agree to settle your bills in full on the day of your reservation by either cash or card payment.
12. Right of admission is reserved.
13. For parties of more than 10 guests, seating may be over more than one table. Large parties may be seated on either the ground floor or top floor of Hudson House depending on availability.
14. A discretionary service charge of 12.5% will be added to your final bill.
15. Please do not bring entertainment/decorations without prior arrangement from Management. Confetti, glitter and party poppers are strictly prohibited and if used there will be a minimum £50 cleaning charge.
16. Please note that we reserve the right to charge the customer up to £1000 in the event of any damage caused to the property or fittings.
17. We regret we cannot accept hen or stag party bookings. Please also note for general bookings that no fancy dress or unsuitable props or decorations are allowed.
